Course Name: Sustainability Communication: Leadership, Ethics, and Laudato Si'

Credit: 3 Credits

COURSE DESCRIPTION

This course examines how communication shapes our understanding of sustainability and environmental stewardship, grounded in ethical reflection and inspired by the moral vision of *Laudato Si'*. It focuses on how leaders, organizations, and communities communicate about the environment—not only about climate, but also about biodiversity, waste, urban ecology, resource use, and community well-being.

Students will explore how faith-based values, ethics, and leadership can transform how people and institutions act toward the environment. Integrating theory, case studies, and reflective practice, the course fosters the development of communication leaders who can inspire change through ethical, empathetic, and inclusive environmental communication.

The course will be delivered online synchronously (via Zoom) and asynchronously (with discussion groups, multimedia resources, and guided reflections).

LEARNING OBJECTIVES

By the end of this course, students will be able to:

- 1. Explain the key concepts and dimensions of sustainability and environmental communication.
- 2. Analyze how leadership and ethics influence human–environment relationships.
- 3. Integrate the moral teachings of *Laudato Si'* and Catholic Social Thought into environmental leadership.
- 4. Design communication strategies that promote environmental responsibility, equity, and care for creation.
- 5. Reflect critically on personal values and leadership roles in promoting sustainable living.

This course uses a blend of reflective and applied learning, with methods such as:

- Short interactive lectures and dialogues
- Case study discussions on communication and environment

- Group projects to design sustainability communication initiatives
